WHAT is the temporary **BUYDOWN** ?

Pays a Lump Sum Upfront

- Reduce Initial Interest Rate Temporarily for the Early Years of the Loan

2/1 Buydown

- 2% Lower Rate in Year 1
- 1% Lower Rate in Year 2
- Note Rate in Years 3-30

1/0 Buydown

- 1% Lower Rate in Year 1
- Note Rate in Years 2-30
